#### **2012 SUMMER CELEBRATIONS**

#### PRESIDENT'S CORNER

Last year was a good year for the White Lake Citizens League and for the residents of White Lake. We celebrated our 50th anniversary with a well-attended Ice Cream Social, which was a great time for kids and adults, and which attracted new members. The annual Memorial Day Pancake Breakfast had record attendance, and has become a great community event that we all look forward to. The fireworks were spectacular! I'm sure we all enjoyed the "Christmas in July" Boat Parade, and the spectacle of weekly sailboat races. The second year of the annual Home Tour was again a success. Weed control was a challenge because of the major onslaught of a relatively new weed called Starry Stonewart, but the treatment program that we coordinated was successful. I also hope that we all feel as I did that the Marine Sheriff Boat Patrols helped to make White Lake a safer lake for many activities.

The good news is that, with the exception of the 50th Anniversary, all of these events will take place again this year. A new, one-day WLCL-sponsored Fishing Tournament is being added this year as well. These events add to the enjoyment of living on White Lake, and are successful because of your support. The fireworks are by far our largest expense. They are funded by your dues and donations (all are recognized on the WLCL website), proceeds from the Memorial Day Pancake Breakfast and the Home Tour, the sale of fundraising merchandise, and donations from local businesses. We will soon conduct our annual membership drive, and the results of previous drives are shown elsewhere in this newsletter. It is always a disappointment to me that fewer than 50% of the residents of White Lake contribute to the fireworks through dues and donations, when I know many more enjoy the fireworks. If you enjoy the fireworks, please contribute what you can. You can not contribute too little or too much.

Later this year, the White Lake Improvement Board (WLIB) will hold a public hearing to consider the budget for the next 3-5 years of the Special Assessment District (SAD). We will propose a budget which continues weed control and Marine Sheriff patrols at their present levels. Depending on the results of a survey and engineering study this spring (funded from the current SAD), we hope to also include funding to dredge the channels leading from the northwest bay to the Beaumont Drive bridge, if affordable. This area has become increasingly difficult to navigate due to the buildup of muck. The WLCL continues to be your advocate to support programs which benefit the residents of our lake.

I'm looking forward to another successful year on White Lake, and to seeing many of you at the activities and meetings this summer.

#### WHERE DOES MY MONEY GO?

Several entities collect money related to White Lake, and it can be confusing ... Below is a summary of some of them:

#### WHITE LAKE SPECIAL ASSESSMENT DISTRICT

**THE MONEY COMES FROM** a special assessment on your Winter Tax Bill (currently lakefront properties pay \$150 per year; lake access properties pay \$18 per year).

**THE MONEY IS USED FOR** lake weed control and water quality testing, dredging and engineering studies, Marine Sheriff patrols, and legal/administrative fees (public hearings, mailings, etc.). Any new uses must be approved at a public hearing.

**THE MONEY IS MANAGED BY** the White Lake Improvement Board (WLIB), consisting of the White Lake and Highland Township Supervisors, an Oakland County Commissioner, a representative of the Oakland County Water Resources Commissioner, and a representative from the White Lake Citizens League. The WLIB delegates administration of the projects to the White Lake Citizens League.

**THE MONEY COMES FROM** voluntary annual memberships (\$25), voluntary donations during the membership drive and at area merchants, profits from the annual Pancake Breakfast and Home Tour, merchandise sales, and business donations (cash and merchandise).

**THE MONEY IS USED FOR** the annual fireworks display, prizes for the boat parade, water quality monitoring and education, MLSA membership, and social events.

**THE MONEY COMES FROM** the "White Lake Level" assessment on your Winter Tax Bill. The assessment is based on the amount of lake frontage of your property.

THE MONEY IS USED FOR operation and maintenance of the augmentation well and pump for the lake.

THE MONEY IS MANAGED BY the Oakland County Water Resources Commissioner.

## **WEED CONTROL**

It came early this year... spring, that is. The ice - what little there was - was essentially gone as of March 3rd. That's the earliest date the ice has melted that I can remember in the 42 years that I've lived on White Lake. That's really good for spirits, but it may also have a lot to do with how much weed growth we will have this spring and summer. While the warm weather and sunlight might have let us get a jump on yard work, docks, and boat launching, it will almost certainly require us to get a jump on weed control as well. It's still a little early to take a cruise around the lake and assess what kind of weed growth we do have, but it looks like we'll be able to get out shortly.

When we moved out to White Lake back in 1970, most of the out-of-control weed growth was Eurasian Water Milfoil and Curly-leaf Pondweed. The species of nuisance weeds has changed through the years with the introduction of exotic weed species to the environment. Today, we still have Milfoil growth areas in the lake, but those areas are much less widespread since we have developed methods for identifying and treating the areas affected with *Sonar* (Fluridone) and 2,4-D.

In the last few years we have acquired an exotic plant called Starry Stonewart. This plant is actually an algae that grows near the bottom. It is so thick that it has the tendency to choke out Milfoil and others plants. In the last couple of years, we have been successful in controlling Stonewart with our strategy of stunting its growth, or what we like to call "giving it a haircut". Since it is almost impossible to eradicate it, this is the strategy we are using.

Since the DNR only permits us to use *Sonar* to treat the entire lake every 4 - 5 years, we would normally be eligible to apply for a permit to use it in 2012. However, since last year's surveys did not reveal enough Milfoil present, the DNR will not permit us to use it this year. Unfortunately, *Sonar* is not effective on Starry Stonewart, at least at the concentrations the DNR permits us to use.

As I mentioned earlier, we do several lake surveys a year to identify weed growth problem areas, and you may see us treating some areas of the lake - but not others - based on the results of these surveys. We also depend heavily on lake resident's calls to the **Hotline** (248-887-5658) to alert us about weed problems we haven't identified. So if there are excessive weeds in your area, please call in and we will respond. Remember also that the lake is not a swimming pool... it is a living, breathing entity. Our goal is not to kill every weed, but rather to control the weed growth so that they are not a nuisance.

Please remember these points to help keep the lake clean:

- 1. Use fertilizer sparingly, and use only low-phosphorous types (sold in Oakland County).
- 2. Have your septic tank pumped every 2 years.
- 3. If you have tree branches hanging over the water's edge, trim them off.
- 4. If possible create a buffer zone of natural plant growth 6 to 8 feet at the shoreline.
- 5. If you are able, keep your shoreline clean by raking the material off the bottom.

#### **DNR INFORMATION**

The Michigan Department of Natural Resources (DNR or MDNR) hosts a unique class of law enforcement officers who regulate outdoor recreational activities such as off-road vehicle use, snowmobiling, hunting, fishing, and boating. They are fully commissioned as state peace officers, with complete authority to enforce Michigan's criminal laws.

No hunting is allowed anywhere on White Lake within White Lake Township, or within 450 feet of any person, home, or private property in Highland Township. Full details of these ordinances are available on our website. Violations should be reported to the **DNR REPORT ALL POACHING HOTLINE at 800-929-7800**. Conservation Officers are equipped with their own boats and can respond and investigate the violations reported.

For non-emergency issues, the WLCL is also fortunate to have a member willing to serve as our DNR Liaison. Patte Day will gladly assist you with any DNR issues, and work on getting a timely response and resolution. Contact her at **DNRliaison@wlcl.org**, or 810-632-6441.

## MARINE SHERIFF PATROLS

Last summer, the Oakland County Sheriff Marine Unit patrolled White Lake for 212 hours on weekend, holiday, and random midweek days. During these patrols, the Sheriff made 623 contacts, conducted 131 safety inspections, and issued 16 tickets and 139

warnings. Detailed statistics provided by the Sheriff's office are available on our website.

These statistics, along with the lack of any serious incidents, and generally favorable informal feedback, convince us that these patrols were helpful in making White Lake a safer place for many activities. The patrols cost just over \$6,600 in 2011 (about \$11 per household, funded from the SAD), and similar funding is budgeted to continue the patrols in 2012. We continue to formally encourage Oakland County to restore county funding for these patrols.

Residents are reminded to report serious incidents or dangerous activity immediately by calling 9-1-1. Those having an issue with the patrol officers are encouraged to contact the Oakland County Marine Sheriff directly at 248-858-1664, and also to let us know by contacting the WLCL Hotline at 248-887-5658 and/or e-mailing us at patrols@wlcl.org.

## TREATMENT NOTICE

## RESIDENTS IN THIS AREA ARE PLANNING TO HAVE THE WATERS IN THIS AREA TREATED WITH HERBICIDES AND ALGAECIDES FOR CONTROL OF AQUATIC WEEDS AND/OR ALGAE.

This notice is being circulated as required by Michigan Department of Environmental Quality (MDEQ) rules. A permit for the treatment has either been secured or will be secured from the MDEQ before the work is begun. In some cases a permit is not required.

You are receiving this notice if you are in the proposed treatment area, or if you are within 100 feet of the proposed treatment area. In some cases, we also provide this notice to persons in adjacent subdivisions as an informational courtesy to advise persons who may have beach rights but are not lakefront residents.

We usually work with groups of homeowners or their elected representatives through homeowners associations, or with the owners of apartment or condominium units. Please try to contact any of these in your situation if you have any questions about the proposed treatment plan.

#### Aqua-Weed Control, Inc. typically does two types of treatments: algae control and weed control.

**Algae Control** - If we are doing only an algae control treatment using only copper based products then no water use restrictions apply. We will post the shoreline with yellow signs informing you of this work as required by the MDEQ.

- □ Lakes Typically lake shorelines are treated twice during the summer.
- Ponds Expect several algae control treatments during the summer beginning in late April thru September.

**Weed Control / Water Dye** - If we are treating for weeds, using blue dye, or using some non-copper algae control products then there are restrictions on the use of the water, and we will post the shoreline with yellow signs before these products are applied to the water body as required by the MDEQ.

We treat each water body according to a schedule or seasonal plan worked out between the persons in charge and an aquatic manager. A typical plan will include multiple treatments from May thru August and possibly September. However, due to the differences in season plans and the uncertainty of weather, please watch your shoreline for the posting of the vellow signs throughout the summer.

#### Typical lake weed control treatment patterns:

- □ If your lake is to be treated with Fluridone then you can expect treatment in late April or early May and then again in mid May.
- ☐ If your lake is to be treated for weeds using other herbicides then you can expect two treatments a summer. The first being in late May or early to mid June. The second application typically is done in mid too late July or early August depending on weed growth patterns. In a few cases a third touch-up weed application may be required.
- □ Ponds are typically treated for weeds twice each summer.

IN MOST CASES YOUR WATER BODY WILL BE TREATED MORE THAN ONCE EACH SEASON; CHECK THIS WITH YOUR ASSOCIATION.

The posted signs will indicate the date of the treatment, the product name, the active ingredient and any restrictions as to the use of the water for swimming, watering lawns and the consumption of fish taken from these waters. We use NEW SIGNS for each treatment.

When more than one product is used the restrictions longest limits will be posted. IF YOU HAVE ANY QUESTIONS PLEASE CONTACT YOUR HOMEOWNERS ASSOCIATION OR NEIGHBORS WHO ARE IN CHARGE OF THE TREATMENT OR YOUR APARTMENT OR CONDOMINIUM MANAGER. If they cannot answer your questions, we can be reached at the number on the other side of this notice.

Only products which have been registered for use in the aquatic environment by the Michigan Department of Agriculture and the US Environmental Protection Agency are used.

We anticipate using one or more of the products listed. Please be aware of the restrictions on each product. If the MDEQ changes any restrictions they will be noted on the signs we post.

PRODUCTS & RESTRICTIONS: (Information below is from product labels. When 2 or more labels exist for a single active ingredient the most stringent information is provided)

**Diquat Dibromide:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). Do not use treated water to irrigate turf or non-food crops for a period of three [3] days after treatment. Do not use the treated water for watering food crops, animal watering (farm stock -- not incidental drinking by a domestic pet), or drinking purposes for a period of five [5] days after treatment. There is no restriction on fish consumption. Diquat dibromide is the active ingredient. No swimming restriction exists on the federal label of this product. Common trade names for this product: Reward, Redwing, Harvester, Littora.

**2,4-D (ester and amine):** Do not use the treated water for swimming for 24 hours. Do not use treated water for irrigating plants, mixing sprays for agricultural or ornamental plants, watering dairy animals, or domestic water supplies for 21 days. "Irrigation" includes watering gardens -- however it does NOT include established grasses. Domestic use means using lake water inside your house. There is no restriction on fish consumption. 2,4-D is the active ingredient. *Common trade names for this product: Navigate, Sculpin. Renovate Max G (also contains Triclopyr)* 

**Triclopyr:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). Do not use treated water for irrigation of any plants except turf grass for 120 days or until the active ingredient has dissipated below a non detectable level as determined by water testing (usually after 2 weeks). This restriction does not apply to established turf grass watering. There is no restriction on fish consumption. Triclopyr is the active ingredient. No swimming restriction exists on the federal label of this product. Common trade names for this product: Renovate (3, OTF, Max G (also contains 2,4-D)), Navitrol.

**Endothall:** Do not use treated water for swimming for 24 hours (MDEQ restriction). Do not use treated water for household uses, animal watering [farm stock], or similar uses for 14 days. Endothall is the active ingredient in each of these products. *No swimming, fishing or turf / ornamentals restriction exists on the federal label of this product. Common trade names for this product: Aquathol-K / Super Aquathol-K / Hydrothol-191(liquid and granular)* 

**Fluridone:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). It is suggested that lawn and garden watering be restricted from 7 to 30 days. The suggested number of days depends on the rate applied and whether you are on a lake or canal and the type of irrigation. The sign we post when we treat will give the details for your area. Fluridone is the active ingredient. There is no restriction on fish consumption. No swimming restriction exists on the federal label of this product. Common trade names for this product: Restore, Avast!, Sonar, WhiteCap.

**Water Dye:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). No restriction for fishing and watering. Organic dye (food grade) is the active ingredient. The label restriction for swimming is "several hours" after application or after even mixing throughout the water body. Common trade names for this product: Cygnet Select, Cygnet Extreme, Pure Blue.

**Copper based algaecides:** NO WATER USE RESTRICTIONS. Copper is the active ingredient. Informational posting only. *Common trade names for this product: Copper Sulfate, Cutrine (Plus, Ultra), Capitan, K-Tea, Symmetry, SeClear, F-30.* 

**Sodium Carbonate Peroxyhydrate:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). No restriction for fishing and watering. Sodium Carbonate Peroxyhydrate is the active ingredient. *No swimming restriction exists on the federal label of this product.* Common trade names for this product: Phycomycin SCP.

**Copper based herbicides:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). Copper is the active ingredient. No restriction for fishing and watering. *No swimming restriction exists on the federal label of this product. Common trade names for this product: Nautique, Komeen, Harpoon(liquid and granular), Current.* 

**Glyphosate:** Do not use the treated water for swimming for 24 hours (MDEQ restriction). No restriction for fishing and watering. The active ingredient is Glyphosate. *No swimming restriction exists on the federal label of this product. Common trade names for this product: Shoreklear, Aqua-Star, Avocent, Aquapro, Aquaneat.* 

**Imazamox:** Do not use the treated water for swimming or irrigation for 24 hours (MDEQ restriction). No restriction for fishing and watering. The active ingredient is Imazamox. *No swimming restriction exists on the federal label of this product. Common trade names for this product:* Clearcast.

**Flumioxazin:** Do not use the treated water for swimming or irrigation for 24 hours (MDEQ restriction). Lawn and garden watering is restricted for 5 days after treatment. No restriction for fishing. The active ingredient is Flumioxazin. *No swimming restriction exists on the federal label of this product. Common trade names for this product: Clipper.*
