- 2) Meeting Minutes approved as written. Larry moved to approve, Sean seconded. Unanimously approved.
- 3) Treasurers Report
 - a. Winter Carnival final expenses \$6,521 (under budget limit of \$7300)
 - b. Includes some onetime expenses: sound system, broomball sticks, and nets
 - c. 2017 year end cash balance is \$532 less than 2015
 - i Includes forward funding summer fireworks deposits through 2021
 - ii Includes two winter carnival events
 - d. Suggestion to have the website request 2018 donations now
 - e. Motion to approve treasurers report by Bill Maine, Seconded by Larry, unanimously approved.
- 4) Newsletter Article
 - a. Request to include the ability to pay by credit card.
 - b. Tom will share copies of last year's articles to have each member update and write new segments for the 2018 newsletter.

- a. Tabled
- 6) Pancake Breakfast
 - a. Denise requesting approval to outsource the cooking & cutlery for the 2018 breakfast
 - i Most years WLCL pancake breakfast hosts around 500 people
 - ii There is a company called Chris Cakes that specializes in hosting pancake breakfasts for charities
 - 1 They are facilitized for mass production
 - 2 They include specialties like blueberry sauce, chocolate chips, etc.
 - 3 Pancakes, sausage, Tang,
 - b. Recommendation to raise price from \$6 to \$7 for 2018 (kids cost raised from \$3-4)
 - c. Past breakfasts have profited about \$3/person and cost about \$1300 in materials
 - d. Chuck make motion to contract to Chris Cakes for the 2018 Memorial Day breakfast. Including a \$400 deposit and min commitment for \$2400 (min 450 people). Seconded by Scott. Unanimously approved.
 - e. Denise made motion to raise prices to \$7 adults/ kids \$4. Seconded by Chuck. Unanimously approved.
- 7) Home & Cottage Tour
 - a. No houses committed to the 2018 tour.
 - b. No committee leader now. Plenty of volunteers.
 - c. Sean will send out a survey to ask whether the June 23 or July 28 date is preferred.
 - d. Tentative plan to have it July 28.
 - e. Tom will host a coordination meeting in about two weeks.
- 8) Fishing Tournament
 - a. Entry fee is \$30 per boat. All proceeds go back into prizes.
 - b. Typically the Saturday of Free Fishing Weekend
 - c. Sat June 9 2018
 - d. Scott wants to add a new category for biggest fish for a kid under 13.
 - e. Scott wants to add an additional tournament in the fall (November)
 - f. Larry moves to have a spring AND fall sessions with a budget of \$75 each. Seconded by Bill. Unanimously passed.
 - g. Chris Kurowski stated that he is leaving the lake after 31 years and 15 years as president of WLCL. Chris will be missed.
- 9) Sailboat Races
 - a. Bill motioned to name the sailboat races after "Richard Gilbert". Seconded by Larry. Unanimously approved.
- 10) Boat Parade July 4th
 - a. No update.
- 11) Fireworks July 4th
 - a. 2018 Fireworks show booked for Saturday June 30, 2018
 - b. On contract through 2021.
 - c. No new info from last meeting.
- 12) Merchandize

 - a. WLCL & WLIB approved plan to conduct a Physical, Chemical & biological study of White Lake.
 - i Last study was the Cleary Report from 1985
 - b. Last Year Sean got one bid from Progressive AE for ~\$20-\$25k
 - c. Sean has requested two additional competitive bids from LakePro Inc. & Restorative Lake Services
 - d. Plan to have 3 quotes, and summary and recommendation for source to March WLCL Board meeting
 - e. Plan to take WLCL recommendation to WLIB for approval
 - f. Plan to kick off source in 2018 (completion in 2019)
- 19) WLIB Actions to support above
 - a. Chuck will continue to work with WLIB to get money to support the lake study
- 20) Sherriff Boat Patrols
 - a. There is a plan to have the Sherriff out again in 2018. Sat & Sunday and heavy traffic days.
- 21) Winter Carnival
 - a. Tom thanked all of the volunteers that planned and executed the Winter Carnival
 - b. Winter carnival was a huge success and great event to bring the community together
- 22) Water Quality Testing
 - a. No Update.

 - a. Request for adding the USCG boat inspections again. Need a volunteer to lead.
