- 5) Boat Parade and Prizes
 - a. Lenny is recruiting corporate donations for prizes
 - b. Theme proposed is Christmas in July
 - c. Suggestion to add a night parade then too
 - d. Lenny stated that he wants to relinquish the merchandizing management this year.
