**1)Approved minutes** from last meeting on September 22, 2021. Motion by Larry D'Angelo, Second by Frank Dyson, Minutes unanimously approved

**2)Treasurer's report** Chuck Neville emailed the recap on finances to all board members. At year end cash balance was \$44,075, uop \$5,186 from the prior year end. WLCL had record receipts for 2021. 2022 April year to date receipts are nearly \$10,000, well ahead of last year. However, donations are only running at 135% of donations vs 165% historically. Expenditures have totaled \$5,014 year to date 2022 which included \$2,200 for last part of winter carnival fireworks, \$1,915 for winter carnival apparel which was fully covered by apparel sale at the winter carnival. Cash balance has grown another \$4,800 year to date 2022. Winter Carnival net cost was \$4,700 setting aside membership receipts which was less than the \$5,500 fireworks cost. Motion to accept the Treasures report by Linda Smallwood, second by Joe Tibus. Report unanimously approved.

Before May meeting need financial numbers to be verified 1 board and 2 non board members John Millington, Larry Bruins and Mike Genter will meet with Chuck to review final 2021 report When annual revenue consistently exceeds \$50,000 there IRS will require a 4 page submission vs the current half page submission. We will look at having the 4 page submission prepared by a CPA when it is required.

**3)Weeds** & Algae is starting slow due to cold weather. First weed treatment will likely be in May for algae. As soon as algae starts to appear, lake will be inspected with Aquaweed. EGLE rules will require kelated copper again this year rather than more effective copper-sulfate. Big weed treatment this year for milfoil probably in late June early July.

4) MLSA Conference No one will be attending. Will monitor MLSA website for information.

**5)Newsletter** is mailed. Joe asked all to read the newsletter and mention it to neighbors.
