In addition to the contracted hours, the OCSO Marine Unit also provided the following to White Lake under our budget and **not billed to White Lake residents**:

On August 22, 2010 there was a Helicopter Crash on White Lake. There were no reported injuries but we had a Marine Deputy working on the lake at the time and assisted FAA, Highland Fire, and Road Patrol in handling the crash investigation. Having a Marine Deputy on scene was a big help in putting their devices into the water to contain the fuel / oil leakage in the lake. The additional hours that were spent with this assist were charged to the Marine Unit budget and not to the White Lake contract.

On September 5, 2010 I put an additional boat staffed with two Marine Deputies for the White Lake "Mardi Gras" event. This is a non-sanctioned event that has grown in size over the years and proved to be a problem with the drinking and fights that take place. This year OCSO Marine Deputies assisted DNRE Conservation Officers with a fight that ended up

in an arrest. OCSO Marine Deputies also assisted in the saving of a life when they observed a woman face down in the lake and were able to pull her from the water and get her to shore for medical treatment. The woman was not conscious and needed follow up treatment at the hospital. If OCSO Marine Deputies did not observe and respond to this incident she surely would have drowned.

We had an additional three Marine / Reserve Deputies that assisted in this detail with donating their time. This was non charged / billed hours that was not reflected in the statistics but documented on log sheets as volunteer service.

On July 3, 2010 we had an additional Reserve Deputy who assisted the Marine Deputy during the White Lake Fireworks show. The night was success with no reported accidents or injuries.

Reserves have also contributed in making occasional checks of the White Lake boat during the summer as scheduled maintenance. This was also volunteer time and not billed to the contract.

2010 was a hot summer and there is no question that the presence of the OCSO Marine Unit on White Lake contributed to it being a safe and relatively uneventful one.
